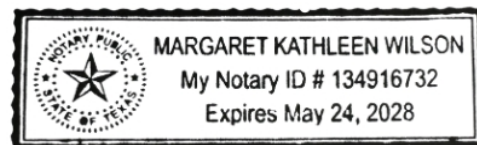

Vrabel’s success could hinge on one factor

Now comes the real intrigue. Yes, Mike Vrabel is back in Foxborough. As expected. A week after Jerod Mayo was fired just minutes after completing his one-and-done season as Bill Belichick’s successor, the New England Patriots made it official on Sunday and named Vrabel as the new coach.

So much for a long, exhaustive search. There was no forest of trees to shake. No bevy of bushes to beat. No search firms, no second interviews, no need to check more references.

Bob Kraft, the charismatic Patriots owner, got his man. And everybody knew this was coming. Even though Vrabel interviewed with the Chicago Bears and New York Jets, and the Las Vegas Raiders seemed like a potential dark horse because of his pal Tom Brady’s fingerprints, it always seemed like a matter of when, not if, he would return.

It’s also no wonder that Aaron Glenn, the hot Detroit Lions coordinator, turned down New England’s request for an interview/intel collection session.

Vrabel was introduced as Patriots coach at noon ET on Monday at the same plaza where he was inducted into the Patriots Hall of Fame in 2023, and the expectations are grand after back-to-back 13-loss seasons. So is the symmetry. A member of three of the franchise’s six Super Bowl champion units, the former linebacker comes back as an accomplished coach – he guided the Tennessee Titans to three playoff berths in six seasons – with presumably all the ingredients to make it work.

No doubt, Kraft’s sentiments are something like: *Come fix this!*

The intrigue, however, will be revealed with the power structure. To get Vrabel, I’m guessing that he gets a lot more personnel clout than Mayo (a first-time coach and former Patriots linebacker, too) worked with.

After all, Vrabel was in his position with the Titans long enough, and with a

degree of success, to know what the alignment needs to be between the personnel and coaching wings. While it’s a major plus that he inherits a promising young quarterback in Drake Maye, how Vrabel meshes with the existing (and/or altered) personnel department looms as a huge component to his chances for success.

Take it from Tedy Bruschi, the former teammate and close friend of Vrabel’s. During ESPN’s “Sunday NFL Countdown,” Bruschi dropped some serious knowledge about the dynamics of the changeover from Mayo to Vrabel.

“When they hired Jerod, at the press conference a big word that was used was ‘collaboration,’” Bruschi, the star analyst, said on the pregame studio show. “Everybody’s input and all that stuff. Well, I don’t know how much it is that anymore. And I think that’s a good thing.”

The Patriots don’t have a general manager and haven’t had anyone carry that title during Kraft’s ownership reign. Belichick, though, was viewed as essentially his own de facto GM, given his autonomy in running the football operation – a generation after Bill Parcells’ differences with Kraft included his desire to “shop for the groceries.”

After Belichick’s departure, Eliot Wolf was promoted to executive vice president of personnel from scouting director, with the power of having the final say on personnel moves. He’s flanked by senior personnel executive Alonzo Highsmith, who joined the Patriots last year.

The bulk of the personnel staff, however, are holdovers from the Belichick era – which is panned for the results in the latter years that left the Patriots with a depleted talent base.

Key question: Will Vrabel have the final say on personnel?

“In my opinion,” Bruschi added on ESPN, “there are some people in the front office that need to be told, ‘You don’t know what you’re doing and you need to take a step back.’”

“Vrabel isn’t going to joke around. Vrabel is going to tighten the screws.”

Which is exactly why Vrabel is such a good hire. Sorry, Mayo.

The process that the Patriots took to get here, though, not so good.

Start with the hiring of Mayo last year. Kraft chose Mayo as Belichick’s successor in 2023, writing a clause into his contract that assured as much. Kraft reasoned that with other teams showing interest in the linebacker coach, he

wanted to lock him up long term. Yet that ultimately prevented the Patriots from conducting a thorough search to replace Belichick. Then Mayo was ultimately undermined because of the weak commitment to stick with him, knowing that it would take a rebuilding job, given the holes in talent.

Here’s to hoping that Mayo, a victim of circumstance with the Patriots, eventually gets another shot at becoming a head coach. Also, another example of a pattern where Black coaches are held to a tougher standard than white coaches – since the Rooney Rule was instituted in 2003, nearly 31% of minority coaches were one-and-done, while less than 10% of white coaches during that span were fired after one season or less – Mayo certainly didn’t get the patience or support that Vrabel’s successor, Brian Callahan, has received from the Titans after finishing 3-14 in his first season.

Of course, Kraft – who could have pursued Vrabel last year if he didn’t already have an agreement with Mayo – opted out of his rookie coach because of the chance to lure one of the most coveted candidates on the market.

It should provide a lesson for any and all team owners: Be very careful in determining your next head coach. Conditions change. The market changes.

With the Patriots, the path to Vrabel also comes with the slew of questions about their quick compliance with the Rooney Rule. Last Tuesday, two days after Mayo was fired, they conducted two former coordinators, Pep Hamilton and Byron Leftwich, who haven’t coached in the NFL since 2022. Were they legitimate candidates?

Perhaps Hamilton and Leftwich have aligned themselves as serious options to become coordinator or assume some other role on Vrabel’s staff. We’ll see. There’s also speculation that Josh McDaniels, the former Patriots coordinator who bombed in head coaching shots with the Denver Broncos and the Raiders, could return to Foxborough.

In any event, in finalizing the multi-year deal with Vrabel on wild-card weekend, the Patriots achieved something during the playoffs that, since Brady left, is no longer the norm.

They scored a big victory.

Commanders’ success sweeter without Snyder

There is something incredibly satisfying about watching the Washington Commanders’ resurgence and knowing that, somewhere, it’s got to be driving Dan Snyder nuts.

For almost a quarter of a century, that miserable, misogynistic and mean-spirited man owned one of the NFL’s crown jewels, and for almost that entire time the team was as awful as he was. Six playoff appearances in 24 years, and only one postseason win this century. Just two seasons with double-digit wins. Scandal after scandal after scandal after scandal.

Snyder finally sold the team in the summer of 2023 and, lo and behold! Two seasons later, the Snyder-less Commanders are back in the playoffs. With the fourth-best record in the NFC, no less.

“Thank you guys for everything,” current Commanders owner Josh Harris told his team after it clinched a playoff berth. “Playoffs!”

Having a winning team in Washington is good for the NFL, which has seen big ratings for Commanders games this season.

It’s good for the long-suffering fans of the franchise, too, who endured one em-

barrassment after another from Snyder.

Mostly, though, it’s good for all of us, who needed to believe that karma would eventually get its due. Who needed the reassurance of knowing you cannot get away with being a garbage human.

Sure, Snyder is still a very wealthy man, thanks to the \$6 billion Harris and his fellow investors paid for the Commanders. He escaped appropriate punishment for a laundry list of wrongdoings, which included sexual harassment of employees and fostering a toxic and abusive workplace.

But the Commanders were Snyder’s lifelong love, his fandom dating back to

when he was a kid and he’d go to games with his dad. Now that the Commanders are finally enjoying success, when they’re no longer among the NFL’s pariahs and pathetics, Snyder has no claim to it.

The Commanders are somebody else’s team now, and the glow of their accomplishments this season is reflecting on someone else. It’s schadenfreude that was long overdue.

Some might say it’s petty to revel in Snyder’s disappointment but ... too bad. Team owners are, often, a pretty shameful bunch. In the NFL alone, Jimmy and Dee Haslam broke the bank to sign an unrepentant sexual predator, then tried to justify it by smearing the women. Houston Texans owner Cal McNair used a racist slur at a team golf outing. Los Angeles Rams owner Stan Kroenke, Los Angeles Chargers owner Dean Spanos and Las Vegas Raiders owner Mark Davis gave their loyal fans the middle finger when they left town to chase shiny new stadiums.

But Snyder was in a class by himself, the worst owner in all of sports.

He clung to his team’s former racist nickname for years, despite overwhelming sentiment against it. Only after sponsors started distancing themselves from the team did he finally relent. He couldn’t get a stadium deal done in Virginia, Maryland OR the District of Columbia.

He was ordered by the NFL to pay \$60 million following an investigation

into allegations of sexual misconduct and financial improprieties against him. This is not to be confused with the \$10 million fine the Commanders had to pay after a previous investigation found a toxic and misogynistic culture permeating the team.

And let’s not forget the congressional investigations of both Snyder and his franchise!

“The Commanders can’t have it both ways,” U.S. Rep. Jamie Raskin, D-Md., said during the House Committee on Oversight and Reform’s June 2022 hearing on allegations of a toxic workplace. “You can’t be constantly asking the public for subsidies and investment, and then not observing basic laws that govern the workplace.”

But Snyder had long acted as if he were above reproach, be it from the NFL, the fans or outside investigators. He didn’t care if he rubbed everyone the wrong way or that he was doing damage to both the franchise and league he claimed to love so much. Snyder was the owner of Washington’s football team, and he was going to do as he damned well pleased.

Except win. That he could never manage, and the Commanders’ quick turnaround under Harris is a further indictment of Snyder’s incompetence.

Getting back to the playoffs is a triumph for the Commanders. Doing it without Snyder gloating and getting the credit makes the resurgence that much sweeter.

NBA MIDSEASON GRADES

Cavs acing tests as Thunder, Celtics lurk

The NBA, at midseason, is entirely wide open.

But just because most teams are at or have surpassed 41 games played doesn't mean it's too early to assess the performance of the entire league.

The NBA hasn't seen a repeat champion since the 2017-18 Golden State Warriors successfully defended their title, and it has become evident the Boston Celtics – winners of last season's NBA Finals – will have legitimate competition. Namely, the Cleveland Cavaliers and Oklahoma City Thunder have each thrived this season, while teams like the Denver Nuggets have heated up.

Boston still is in excellent position, but the Celtics have stumbled recently, raising questions about their viability to repeat.

Here are grades for every NBA team at the midway point season.

ATLANTIC DIVISION

Boston Celtics (29-13)

The defending champions have the third-best winning percentage in the NBA but have lost eight of their past 16 games as they sometimes rely too much on the 3-point shot. Still, Boston has all the pieces to become the first defending champs in six seasons.

Grade: B

New York Knicks (27-16)

It's not easy incorporating new pieces to an already-established contender, but Tom Thibodeau has made the Knicks an offensive juggernaut, as Karl-Anthony Towns is having a career year.

Grade: A-

Philadelphia 76ers (15-26)

Things had started to look better once Joel Embiid, Tyrese Maxey and Paul George all had more time on the floor together, but Philadelphia has lost six consecutive games and nine of its past 11, as Embiid is dealing with another injury issue.

Grade: D+

Brooklyn Nets (14-29)

It just seems the Nets won't be competitive this season, and with their stash of draft picks, this feels like a team that is just building for the offseason.

Grade: C

Toronto Raptors (10-32)

It's bad when the most interesting things about Toronto have been Scottie Barnes, the fallout from the Jontay Porter gambling scandal and the team's ineffective play, stamped by its 54-point loss New Year's Eve against the Celtics – the most lopsided defeat in franchise history. Yet just last week Toronto took down Boston by 13 points.

Grade: D+

CENTRAL DIVISION

Cleveland Cavaliers (35-6)

The Cavaliers have the best record in the NBA, the No. 1 offense, the No. 2 net

rating, an outstanding starting unit, a deep bench and a great coach.

Grade: A

Indiana Pacers (24-19)

The Pacers have overcome a slow start, won eight of their past nine games and are closing in on Milwaukee for fourth place in the East.

Grade: B

Milwaukee Bucks (24-17)

Battling Indiana and Detroit for second place in the division is not where the Bucks expected to be, but a four-game winning streak and winning seven of eight has the Bucks tracking in the right direction.

Grade: B

Detroit Pistons (21-21)

The Pistons are headed for the play-in game at least and possibly a top-six seed, and Cade Cunningham's production is a significant development.

Grade: B+

Chicago Bulls (18-25)

Not good enough and not bad enough, the Bulls are stuck in no man's land and in danger of losing their 2025 first-round pick if the pick falls outside of the top 10.

Grade: C-

SOUTHEAST DIVISION

Orlando Magic (23-21)

Behind defense and the emergence of Jalen Suggs, Jamahl Mosley's Magic weathered the absences of Paolo Banchero – who has returned – and Franz Wagner (oblique) to stay competitive the East.

Grade: A-

Miami Heat (21-20)

Amid the Jimmy Butler drama, the inconsistent Heat have remained in the play-in window. But in Year Six of the Butler-Bam Adebayo-Tyler Herro build, a transition is becoming necessary.

Grade: C

Atlanta Hawks (22-19)

They've had some young players make significant jumps – none more than Jalen Johnson and Dyson Daniels – but Atlanta can be rather inefficient on offense, despite its ball movement.

Grade: B

Charlotte Hornets (10-28)

LaMelo Ball is in line to start the All-Star game, but Charlotte's offense is nonetheless broken; Ball's high-volume shot portfolio – he leads the NBA in attempts per game and 3-point attempts – has made Charlotte one-dimensional and inefficient. In fact, the Hornets have the top two players in 3s attempted per game, with Brandon Miller second at 10.9 per. The roster needs help.

Grade: D+

Washington Wizards (6-35)

As they have most of the season, the Wizards are last in offensive rating, defensive rating and net rating. But Washington at least has young pieces in place that could signal a potential jump.

Grade: D

NORTHWEST DIVISION

Oklahoma City Thunder (35-7)

Shai Gilgeous-Alexander leads the best team in the West, and like Cleveland, the Thunder have a strong starting unit, a deep bench and one of the league's top coaches. They have also flourished without one of their best players, Chet Holmgren, who is sidelined with a hip injury.

Grade: A

Denver Nuggets (26-16)

Since an 11-10 start, the Nuggets are 15-6 and have won six of the past seven.

Grade: B

Minnesota Timberwolves (22-20)

It's tough to win in the West, and the Timberwolves are proof of that. After reaching the conference finals last season, they're in a play-in spot today.

Grade: C

Portland Trail Blazers (14-28)

Improving over last season, the rebuild is slowly moving forward under fourth-year coach Chauncey Billups.

Grade: C

Utah Jazz (10-30)

It's going to be a long few seasons as the Jazz map out a future.

Grade: C-

PACIFIC DIVISION

Los Angeles Lakers (22-18)

A middle of the pack team, the Lakers

could finish as high as No. 4 or miss the playoffs.

Grade: B-

Los Angeles Clippers (24-17)

Kawhi Leonard's 34-game absence to start the season didn't help.

Grade: B-

Sacramento Kings (22-20)

The Kings fired Mike Brown on Dec. 27 after giving him extension in the offseason and are clinging to a spot in the play-in game.

Grade: C

Phoenix Suns (21-20)

Playing .500 ball isn't going to get the Suns anywhere.

Grade: C

Golden State Warriors (21-20)

The Warriors' 12-3 start has been erased by 17 losses in their past 26 games.

Grade: C

SOUTHWEST DIVISION

Houston Rockets (28-13)

They're still incredibly young and still finding their identity. Defense and athleticism have carried them, though they will eventually need to find a little more offensive efficiency, as the Rockets are tied for 25th in true shooting percentage (54.8%).

Grade: A

Memphis Grizzlies (27-15)

Memphis is another young team, and it has gotten excellent contributions from its stellar rookie class in the form of Jaylen Wells and Zach Edey. With Ja Morant fully healthy, this is a team to watch in the second half.

Dallas Mavericks (23-19)

The Mavericks have faced unfortunate injury issues with Luka Doncic sidelined indefinitely and Kyrie Irving back from a lumbar sprain. A Western Conference championship repeat looks unlikely, as Klay Thompson has been solid, if unspectacular, in Dallas.

San Antonio Spurs (19-22)

The Spurs have found something special in Stephon Castle, and Victor Wembanyama remains a unicorn. San Antonio is close to matching its win total from last season. Now it's time to bolster the roster.

New Orleans Pelicans (11-32)

The team to face the worst injury luck to start the season, the Pelicans could be sellers at the trading deadline. New Orleans is on a little three-game winning streak, however, but it needs to solve the issue of Zion Williamson – who has appeared in just 10 games – and his constant lack of availability.
